The motivation and engagement in this piece of learning has been phenomenal and a joy to see. I was particularly impressed with the peer to peer interactions and the thoughtfulness of the students.

As we move towards the second half of the term, we have lots of exciting things planned so do keep an eye on the calendar dates!

**The Big Ambition** - The Children's Commissioner for England, Dame Rachel de Souza, has launched The Big Ambition, a national survey of children and young people across England.

The Big Ambition aims to hear from children across England on what they think is important! In the lead up to the next General Election, the Children's Commissioner wants to take children's thoughts, opinions and ideas to decision-makers, to make sure that the Government hears young people's voices on what they think needs to be done to make children's lives better in England. The survey is open until Friday 15th December.

In case you haven't heard, the Department of Health and Social Care (DHSC) has issued a [National Patient Safety Alert](#) on supply disruptions affecting various strengths of the following medications for the treatment of attention deficit hyperactivity disorder (ADHD):

- Methylphenidate\*
- Lisdexamfetamine
- Guanfacine

The supply disruption is caused by a combination of manufacturing issues and an increased global demand. Other ADHD products remain available but cannot meet excessive increases in demand.

At present, the supply disruptions are expected to resolve at various dates between October and December 2023.

The Dept has advised there may therefore be children and young people who have had to change their medication, may be missing doses, or where treatment breaks are planned or enforced as a result of the current situation. Please contact your GP if you are concerned.


Following the Ofsted visits, we are aware of our strengths and what we need to do to improve in some areas, and we will be supporting the schools to this end.

Over the summer, Su Aves and Deb Norman decided to step down as Governors after several years of service. Steve Cleverly, longstanding Governor at the Federation and the Chair for several years, has just retired from the Board. Jordan Conibere has joined the Governing Body, following a vote by staff and Tom Bates has chosen to stay on as a Governor to continue supporting the school strategically. Governors must govern in the best interest of all pupils and the whole Federation; it is not their role to represent a particular group. Stakeholder engagement is an important, but distinct, activity with appropriate structures and arrangements in place.

Life as a governor is interesting and varied and we feel sure that there are parents prepared to take on this important role and give their time and commitment to helping us to continue to improve the Federation's performance.

Training and support will be available to help you develop into the role. The standard term of office for parent governors is 4 years (although you can step down before that if required) and Governors meet at least twice every half term (6 weeks) for meetings, as well as carrying out occasional Monitoring Walks at the schools, and attending events like sports days, careers meetings etc.

## Disqualification criteria

A person is disqualified from holding or from continuing to hold office as a governor or associate member if he or she:

- fails to attend the governing body meetings – without the consent of the governing body – for a continuous period of six months, beginning with the date of the first meeting missed (not applicable to ex officio governors);
- is subject to a bankruptcy restriction order, an interim bankruptcy restriction order, a debt relief order or an interim debt relief order;
- has had his or her estate sequestrated and the sequestration order has not been discharged, annulled or reduced;
- is subject to:
  - I. a disqualification order or disqualification undertaking under the Company Directors Disqualification Act 1986
  - II. a disqualification order under Part 2 of the Companies (Northern Ireland) Order 1989
  - III. a disqualification undertaking accepted under the Company Directors Disqualification (Northern Ireland) Order 2002
  - IV. an order made under Section 429(2)(b) of the Insolvency Act 1986 (failure to pay under a County Court administration order);
- has been removed from the office of charity trustee or trustee for a charity by the Charity Commissioners or High Court on grounds of any misconduct or mismanagement, or under Section 34 of the Charities and Trustees Investment (Scotland) Act 2005 from participating in the management or control of any body;
- is included in the list of people considered by the Secretary of State as unsuitable to work with children;
- is disqualified from working with children or subject to a direction under Section 142 of the Education Act 2002;
- is disqualified from registration for childminding or providing day care;
- is disqualified from registration under Part 3 of the Childcare Act 2006;
- has received a sentence of imprisonment (whether suspended or not) for a period of not less than three months (without the option of a fine) in the five years before becoming a governor or since becoming a governor;
